

Good Morning Everyone,

Just an update on the city campaign this year:

Chief's Corner

Reminder: All radio traffic is recorded. Not only recorded but subject to QA Review. Some are automatically subject to in-house review by the Emergency Communications District. Even though this protocol is for Dispatchers, our transmissions are part of the process and in the reviews.

See below the paragraphs from the Hamblen County Emergency Communications District. OPS-05, page 2.

D. All recorded communications within the District may be subject to quality assurance reviews. This includes, but is not limited to, the following:

- 1. telephone conversations,
- 2. text-to-911 sessions,
- 3. radio dispatch (includes side channel traffic),
- 4. e-mail correspondence, and
- 5. any other recorded communication.

E. While all recorded communications occurring with the District may be subject to QA reviews, the reviews will generally focus on calls for service that represent <u>time life critical events</u>. These events include, but are not limited to, the following:

- 1. Airway Obstruction
- 2. Cardiac Arrest / Heart Attack / Chest Pain
- 3. Gunshot Wound
- 4. OB CFS (Labor / Delivered / Hemorrhage)
- 5. Stabbing
- 6. Stroke
- 7. Structure Fire (Confirmed)
- 8. Unconscious / Semi-Conscious

THE JEWEL OF EAST TENNESSEE

That's what Sports Facilities Management, Inc.'s Greg Wisecarver says he expects Morristown's new Community Center to be known as. The designated GM for the facility, which will see construction begin this Fall, presented the August 21 City Council planning retreat with design plans outlining what citizens can expect.

"Cradle to grave" is the age span of activities we intend to include. Swimming, fitness, basketball, volleyball, track, climbing, and E-sports competition rooms, and more will be among the choices.

The Community Center will be adjacent the Merchants Greene shopping complex which is fed into from Highways 160 and 11E, West A. J. Highway, and Exit 4 of Interstate 81. The CC will also have meeting and classroom options.

Sports Facilitites Mangement was chosen to be the operations company by a panel of city staff and Councilmember Kay Senter. SFM manages multiple sports complexes throughout the USA. It intends to blend ongoing regional activities with local Parks and Recreation athletic programs. Opening is projected for April, 2022.
