NOW WHEREAS, the above mentioned Principal desires to engage in the work  
of installation, extension, or alteration of consumer's gas piping or gas appliances in  
the City of Morristown, such work being governed and regulated by Ordinance No.  
1647 of the City of Morristown.

NOW THEREFORE, the condition of the obligation is that the said Principal  
shall faithfully observe all the laws pertaining to said work and further, that the  
Mayor and Aldermen of the City of Morristown shall be indemnified and saved harm  
from all claims arising from accidents and/or damages of any character whatsoever  
caused by the acts of said Principal or by any other unfaithful work done by said  
Principal, or his agents or employees and that said Principal will faithfully perform all  
such work entered upon or contracted for, in strict accordance and compliance with  
the provisions of said ordinance.

This bond may be cancelled by giving thirty (30) days written notice of such  
cancellation by registered mail to the Building Official's Office of the City of  
Morristown.

KNOW ALL MEN BY THESE PRESENTS: That \_\_\_\_\_ as Principal, and \_\_\_\_\_ as surety, are holden and bound unto the Mayor and Aldermen of the City Of Morristown, Tennessee, in the sum of \$5,000.00, to the payment of which sum to the Mayor and Aldermen of the City of Morristown, we hereby jointly and severally bind ourselves, our heirs, successors, and personal representatives. Now, whereas, the above-mentioned Principle is a **plumber** engaged in general plumbing work and desires to do such work within the corporate limits of the City of Morristown, Tennessee.

Now, therefore the condition of the obligation is that the said Principal shall faithfully observe all the laws pertaining to plumbing, drain laying, blasting, and excavating and further, that the Board of Mayor and Aldermen of the City of Morristown shall be indemnified and saved harmless from all claims arising from accidents and damage of any character whatsoever caused by the negligence of said Principal or by any other unfaithful work done by said Principal or his (their) agents or employee and that said Principal will maintain in a safe condition for a period of one year all ditches and excavation which may be opened in the performance of any plumbing work, and further that all dirt and other material excavated will be replaced in good condition with similar material.

This bond may be cancelled by giving thirty (30) days written notice of such cancellation by registered mail to the Building Official's Office of the City of Morristown.

If said Principal faithfully keeps all said conditions, then this obligation shall be null and void; otherwise, it shall remain in full force and effect.
