FEBRUARY 5, 2008**

The City Council for the City of Morristown, Hamblen County, Tennessee, met in regular session at the regular meeting place of the Council in the Morristown City Center at 4:00 p.m., Tuesday, February 5, 2008 with Honorable Mayor Barbara C. "Sami" Barile presiding and the following named Councilmembers present: Claude Jinks, William Rooney, Kay Senter, Rick Trent and Mel Tucker; and the following named Councilmember absent: Frank McGuffin.

Councilmember Jinks made a motion to approve the January 15, 2008 minutes as circulated; Councilmember Rooney seconded the motion and all voted "aye".

Councilmember Senter made a motion to approve the January 29, 2008 called meeting minutes as circulated; Councilmember Jinks seconded the motion and all voted "aye".

Councilmember Jinks made a motion to approve the honorary designation of "Evelyn B. Johnson Way" as a secondary street name for Old Highway 11-E; Councilmember Tucker seconded the motion and upon roll call, all voted "aye".

Councilmember Jinks made a motion to accept Chief Overholt's recommendation and hire Dwayne Collins as an entry-level police officer; Councilmember Rooney seconded the motion and upon roll call, all voted "aye".

Councilmember Jinks made a motion to accept Chief Overholt's recommendation and hire Marc Bass, Ronald Hall, Terry Costner, Diana Holmes, Brad Jacobs, Bruce Rudis, Phillip Stubblefield, Bradley French, Brad Rice and Yancy Cothorn as entry-level police officers; Councilmember Tucker seconded the motion and upon roll call, all voted "aye".

A public hearing was conducted on the following captioned Ordinance No. 3317. Councilmember Jinks made a motion to adopt said Ordinance on second and final reading; Councilmember Rooney seconded the motion and upon roll call, all voted "aye".

**Ordinance No. 3317  
Entitled an Ordinance to amend the Municipal Code of the City of Morristown, Tennessee, Appendix B. {Rezoning of property located at the corner of Cherokee Drive/Morgan Lane/Walters Drive (Parcels 27.01 & 27.05, Tax Map 33) from Medium Density Residential (R-2) and Planned Single Family Residential (RP-1) to Mixed Use District (MUD).}**

A public hearing was conducted on the following captioned Ordinance No. 3318. Councilmember Senter made a motion to adopt said Ordinance on first reading; Councilmember Rooney seconded the motion and upon roll call, all voted "aye".

**Ordinance No. 3318  
Entitled an Ordinance to amend the Fiscal Year 2007 Budget by providing for appropriations from revenue and expenditure accounts on an individual fund and line item basis.**

Councilmember Tucker made a motion to open the agenda and add an item regarding the bid for police vehicles; Councilmember Jinks seconded the motion and upon roll call, all voted "aye".

Councilmember Tucker made a motion to re-approve the August 21, 2007 bids for four SUV's for the Police Department from Morristown Ford at a cost of \$22,806.32 each. Councilmember Trent seconded the motion and upon roll call, all voted "aye".

Councilmember Tucker made a motion to approve change orders to All Star Construction's contract for the ADA Skywalk Renovations in the amount of \$58,008; Councilmember Trent seconded the motion and upon roll call, all voted "aye".

Councilmember Senter made a motion to adopt the Parks & Recreation Department's Comprehensive Recreation Plan as presented. Councilmember Trent seconded the motion and upon roll call, all voted "aye".

Councilmember Rooney made a motion to adopt the Parks & Recreation Department's Fees and Charges Policy as presented. Councilmember Trent seconded the motion and upon roll call, all voted "aye".

Councilmember Trent made a motion that as a declaration of policy "no items will be considered by Council unless included in the Council Agenda Packets sent out on Friday prior to the Council meeting". Councilmember Senter seconded the motion and upon roll call, all voted "aye".

Mayor Barile adjourned the February 5, 2008 City Council meeting.
