The City Council for the City of Morristown, Hamblen County, Tennessee, met in regular session at the regular meeting place of the Council in the Morristown City Center at 4:00 p.m., Tuesday, September 21, 2010 with Honorable Mayor Barbara C. "Sami" Barile, presiding and the following named Councilmembers present: Gene Brooks, Bob Garrett, Frank McGuffin and William Rooney; Councilmembers absent: Claude Jinks and Kay Senter.

Councilmember McGuffin made a motion to approve the September 7, 2010 minutes as circulated; Councilmember Rooney seconded the motion and all voted "aye".
