

Notice of Public Meetings to be held on The Community Development Block Grant (CDBG)  
2017 Draft Action Plan, City of Morristown, TN

This notice is to inform the citizens of Morristown, TN of public meetings to be held on April 6, 2017 at 12:00pm-1:00pm and April 20 1, 2017 at 4:30 pm-5:30pm. These public meetings will provide the citizens of Morristown, public agencies, and interested parties an opportunity to express views regarding the community development related needs of our community and uses of the 2017 CDBG entitlement funds as they are addressed in our 2017 Draft Action Plan. This plan (a result of previous needs notifications and hearings) will be made available to the public on April 4, 2017 at Morristown-Hamblen Library, Morristown Utilities, the Chamber of Commerce, online at [www.mymorristown.com](http://www.mymorristown.com), several local non-profits, and Morristown City Center Planning Department. The meetings will be held at the Morristown City Center Planning Department conference room (100 W. 1<sup>st</sup> N. St., Morristown, TN 37813. 423-585-1834). Interested parties are encouraged to comment at the public hearings or by May 1, 2017.

Entitlement funds for the 2017 program are estimated to be \$245,000. The current draft plan proposes funding;

Homeowner rehab/Emergency Assistance	\$ 90,000.00
Parks and Recreation	\$ 20,500.00
Rose Center	\$ 20,500.00
MHCS Homeless prevention program	\$ 10,000.00
TVCH CoC HUD HMIS Program	\$ 5,000.00
Façade Economic Development Program	\$ 50,000.00
Administration (20%)	\$ 48,414.40
TOTAL	\$245,000.00

The final Plan will be presented to City Council for approval on May 2, 2017 and submitted to HUD for approval no later than May 15, 2016.

Interested parties are again encouraged to comment at the public hearings or by May 5, 2017.

At least 70% of the CDBG funds received will benefit areas with low to moderate income.

CDBG program funds may be used for;

- Acquisition of real property.
- Relocation and demolition.
- Rehabilitation of residential and non-residential structures.
- Construction of public facilities and improvements
- Public services, within certain limits.
- Activities relating to energy conservation and renewable energy resources.
- Provision of assistance to profit motivated businesses to carry out economic development and job creation/retention activities.
